## **Primary Purpose:**

Performs highly responsible technical, administrative, and supervisory work directing and coordinating operations and maintenance of a 14.7 million gallon per day (MGD) surface water treatment facility, transmission system, water storage facilities, and pumping stations.

## **Essential Duties and / or Responsibilities:**

The following is a summary of the essential functions for this job. Other duties may be performed, both major and minor, which are not mentioned below. Specific activities may change from time to time.

- Act as the Operator in Responsible Charge (ORC) for overall plant operations. As the ORC, this position is legally responsible and accountable to regulatory authorities on behalf of PTRWA.
- Direct/indirect supervision over all operations staff.
- Provide knowledge and training on safety program requirements for water plant employees.
- Serves as the company representative on the Local Emergency Planning Committee
- Prepare Standard Operating Procedures (SOPs).
- Order bulk chemicals and maintain chemical inventories.
- Provide input on capital improvement project (CIP) planning.
- Coordinate with the maintenance division on repair activities.
- Purchase order procurement/reconciliation.
- General oversight of the operations budget.

## **Minimum Required Skills or Competencies:**

The requirements listed below are representative of the knowledge, skill and/or ability required. Reasonable accommodation may be made to enable individuals with disabilities to perform the essential functions.

- Bachelor's degree in chemistry, engineering, environmental or related studies.
- Class "A" North Carolina Water Operations Certification.
- Physical Chemical Grade 1
- 10+ years of experience operating a Class "A" treatment facility.
- 5+ years of experience in a supervisory capacity.
- Understands and demonstrates knowledge and experience with surface water treatment techniques, regulatory requirements, and water quality administrative controls and procedures.
- Ability to perform general physical activities that may include sitting, standing, walking, talking, seeing, hearing, lifting, reaching, climbing, and repetitive motions.
- Ability to exercise independent judgment and decision making in routine and emergency situations.
